All the first board of trustees shall be the Life Trustees. All the trustees shall anonymously select/nominate in the place of Life Trustee causing the vacancy.

3. The Board of Trustees shall from time to time determine the number of Trustees for the Trust Board but the total number of Trustees shall not less than two.

4. The Founder of the Trust Mr.C.MURUGAN shall be the first Managing Trustee for Life and he shall be entitled to nominate the next Managing Trustee for life. Should a vacancy arise in the office of the Managing Trustee either by a failure to nominate or otherwise by non acceptance of the office by the nominee or otherwise by affix of time the remaining Trustee shall elect / Select a Managing Trustee on such a terms for such periods as may be specified by a resolution of the Board of Trustees/Management. The day to day affairs of the trust shall be carried on by Mr.C.MURUGAN the Managing Trustee.

5. The Board of Trustees shall have Power.

a) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust

b) To open and maintain Bank accounts in the name of the Trust operated by the Managing Trustee with any Bank or Banks from time to time decide and all moneys so far as possible, shall be paid in such account or accounts and the Managing Trustee shall be entitled to operate such account or accounts.

c) The Trustees shall have full power to maintain the Trust funds and to compromises or compound all actions, Suits and other proceedings and all differences and demands and refer any such differences or demands to arbitration and to adjust, settle and approve all accounts relating to the Trust Funds only for the welfare of the Trust and to execute releases and all documents necessary in the promises and to do all other things relating thereto respectively as fully as if they were absolute responsible to the Trust Funds and without being answerable for the loss occasioned thereby.

d) The Board of Trustees shall meet as often as necessary or at least once during every six months at the registered office of the Trust or at such place as they may decide.

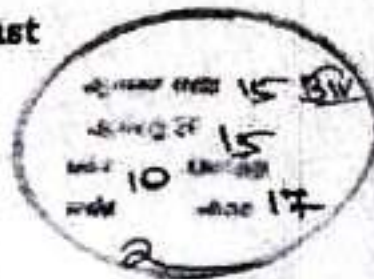
e) The Chairman of the meeting shall be the Managing Trustee or any other Trustee mutually agreed upon.

g) The Board of the Trustees shall also be competent to pass any resolution by circulations among them. The secretary of the Trust shall maintain the minutes of the proceedings. The treasurer of the Trust shall maintain proper full accounts for all the funds, monies and assets of the Trust. The accounts of the Trust shall be closed on 31st December every year and it should be audited by a Chartered Accountant. The Board of Trustees shall act as a man of ordinary prudence with care and interest in discharging duties diligently and faithfully for the greatest advantage to achieve the objectives of the Trust. A Trustee shall cease to hold office as Trustee in the following circumstances:

i. On being adjudged as an insolvent by a Court of competent jurisdiction.

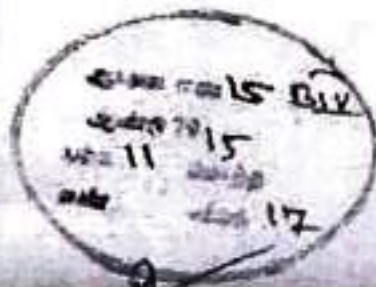
ii. By becoming insane or adjudged as a lunatic under the Indian Lunacy Act.

iii. On being convicted by the criminal Court for an offence involving moral turpitude.

The Board shall be entitled to make and prescribe from time to time rules and by-laws and regulations for carrying the object of the Trust and also modify or amend such by-laws and rules and regulations within the frame work of the Trust.

The Trustees are not entitled for any remuneration. Further the Income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way profits, interest, dividend or otherwise.

For matters not provided for in these presents, the provisions of the Indian Trust Act and the Income Tax Act, 1961 and rules made there under will apply accordingly.

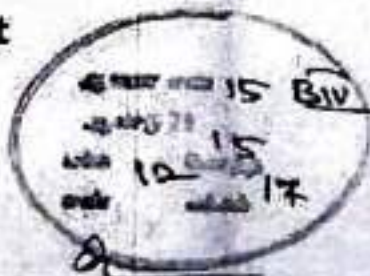



The Trustees decided to register the Trust deed at Sub-Registrar Office, Alangulam.

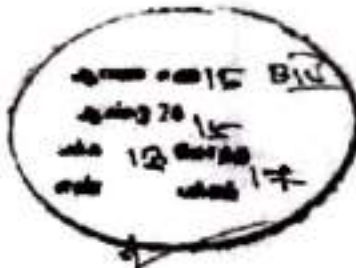
