- 9. The Institution Premises must be kept neat and clean always.
- 10. Toilets and Urinals must be kept Hygienically clean and Adequate water supply should be provided.
- 11.Keep the premises free from Mosquito breeding sources.
- 12. There shall not be any thatched structure in the premises.
- 13. Substantial Repairs should be done then and there.
- 14.Garbage must be removed daily and should be disposed safely as per solid waste Management Rules.
- 15." No Smoking Zone" Board Should be Disposed prominently inside the campus.
- 16. Soap stand with soap should be provided in all toilets.
- 17.If any communicable diseases or suspected disease found in the premises, immediately inform the same to the concerned PHC Medical Officer.
- 18. Then and there the institution must co- operate with the public health program implemented by the department and Government,
- 19. Prohibit disposable Plastic Materials in the institution premises.
- 20. Sanitary Certificate may be cancelled if any discrepancies or deviations found in future.
- 21. Sanitary Certificate should be Renewed Every Year.
